IDEXX Shelter Savings Enrollment Instructions

For nonprofit organizations:

1. Complete the enrollment form by filling in your organization's name, billing/shipping address, telephone number, fax number, e-mail address. **Must provide physical address for shipping. (No P.O. boxes will be accepted.) Bill to and ship to address must be a non-profit location.**
2. Have a veterinarian sign, date, and print his/her name and state license number where indicated. IDEXX will accept signatures from non-staff veterinarians you work with on a regular basis and who are willing to certify that the SNAP[®] products purchased will be used solely to test animals for your nonprofit organization.
3. Attach a copy of your proof of nonprofit status. IDEXX will accept the following as proof of nonprofit status:
Accepted
 - IRS determination letter (verifying 501(c)(3) status)
 - For subsidiaries: IRS determination letter and documentation proving subordinate /subsidiary status
 - IRS Form 990/state equivalent state
 - State certificate of registration**Not Accepted**
 - Employer identification number
 - Federal nonprofit identification number
 - Sales and use tax exemption certificate*
 - Printouts from online databases
4. When completing the enrollment form, be sure that the organization name matches the name appearing on your proof of nonprofit status. **If you use a trade/assumed name ("doing business as") and wish to enroll under that name, you must also provide a copy of your registration of that name.**

*IDEXX will review sales and use tax exemption certificates on a case-by-case basis and determine for itself whether the certificate indicates that your organization is a nonprofit. Blank certificates completed by you will not be accepted as proof, nor will certificates that do not plainly state that your organization is a nonprofit/charity.

For government agencies/military units/educational institutions:

1. Complete the enrollment form by filling in your organization's name, billing/shipping address, telephone number, fax number, and e-mail address. **Must provide physical address for shipping. (No P.O. boxes will be accepted.) Bill to and ship to address must be a non-profit location.**
2. Have a veterinarian sign, date, and print his/her name and state license number where indicated. IDEXX will accept signatures from non-staff veterinarians you work with on a regular basis and who are willing to certify that the SNAP[®] products purchased will be used solely to test animals for your nonprofit organization.
3. Proof of nonprofit status: Government agencies (e.g., animal control), education institutions, (e.g., university department or research program) or military units (e.g., veterinarians on base) must submit a blank copy of the official letterhead indicating that your department is a division of a government agency, educational institution or military unit.
